Policy: MSCOD advises the Governor, state legislature, state agencies, and local units of government on issues affecting Minnesotans with disabilities. We analyze legislative initiatives and advise how proposed policies will impact the disability community. Our goal is to ensure all policymakers understand the effects of their decisions on Minnesotans with disabilities.

Training: MSCOD provides customized training on a variety of issues including disability awareness, emergency preparedness, building access, advancing the rights of people with disabilities, and more.

Technical: MSCOD is a technical expert on numerous disability matters, including disability parking, transportation access, compliance with the Americans with Disabilities Act, building codes, assistive technology, accessibility, and employment rights.

## Celebrating the ADA's Legacy

During the 2013 legislative session, MSCOD received a \$400,000 Arts and Cultural Heritage Legacy grant, in partnership with the Minnesota Humanities Center, to celebrate the Americans with Disabilities Act's 25th anniversary in 2015. The grant will be used to fund an ADA survey, a history of Minnesota's role in achieving ADA passage, a theatrical production highlighting disability employment issues, and a training/education event celebrating the ADA's 25th anniversary. #### A State Resource

One of MSCOD's most important duties is being a resource for other state agencies and government committees. Since its inception, MSCOD has served on hundreds of committees that impact Minnesotans with disabilities. That work continues today. MSCOD sits on the Metropolitan Council Transportation Accessibility Advisory Committee, the MnCHOICES Steering Committee, the Secretary of State's Disability Advisory Committee, committees focused on accessibility of the new Vikings stadium, Saints ballpark, and the Capitol complex, and many others. Serving on state and community committees allows MSCOD to stay abreast of current issues and collaborate with stakeholders on many issues.

### MSCOD'S 2013 HIGHLIGHTS



MSCOD State Fair Booth

- Received an increased appropriation to fund emergency preparedness activities.
- Worked to ensure the new Vikings stadium, Saints ballpark, and legislative office building are accessible.
- Created two changes in parking laws that will help Minnesota drivers with disabilities.
- Hosted a US State Department fellow from Azerbaijan and introduced him to Minnesota's disability community.
- Supported a bill that brought Minnesota law regarding service animals into federal ADA compliance.
- Received a \$400,000 Minnesota Legacy grant to fund activities surrounding the ADA's 25th anniversary in 2015.
- Supported a law that created no-excuse absentee voting.
- Distributed over 13,000 emergency preparedness bags at the Minnesota State Fair to help Minnesotans to be prepared in case of an emergency.
- Received over 80% satisfaction rating as measured by our annual satisfaction survey.
