Events

- MN History Center Family Day
 - Craig is working with the History Center to finalize the lineup of performers.
 - There will be a "Decorate your mobility device" activity.
 - Duane Zott is booked for a visual arts activity. Other activities include educational worksheets and making nameplates in braille.
 - Two more performers need to be confirmed.
 - Diverse acts confirmed, including a Duluth music and dance group, Treading North band, Jimmy Hanson's band, and Paul Maybon.
 - Details for the videos we want to show are being finalized.
 - We are working on confirming speakers.
 - Karen is working on volunteers and is confident that we will have more than enough.
 - Linda G and Marie will coordinate translators.
 - Parking lots have been secured, and we are working on a shuttle bus with five wheelchair tie downs.
- October Conference
 - Venue is the Minneapolis Convention Center, and the RFP process is done. Contract will be signed soon.
 - Ten rooms, which can open up to a big room, plus another large room. There is good space for vendors, etc.
 - We need to determine breakout speakers. Mark suggests Diane DuGay for one or both conferences. Joan suggests Loretta Lynch or someone from DOJ to do a breakout.
 - Title of the event is The ADA at 25: Minnesota Moving Forward.

Survey

• 300+ responses so far, with a goal of 1,000. Surveys are being distributed at various conferences.

Communications

- Web Update
 - Microsite is live: www.mscod25ada.com. We will be adding a disability resources section.
 - Gillette video is done, but has closed instead of open captions. Final language for audio description is being reviewed.

Documentary

- Tpt needs someone from greater MN to be a documentary subject. Linda G
 is working on it.
- Documentary will be a part of the Family Day.
- First airing is on 7/26 at 8pm, and then it will be in circulation for a short time. It will then be put on the shelf until the October event.
- Tpt is referring everyone to our microsite, which includes a tpt section. Tpt
 is not making their website fully accessible in the near future, so this is a
 compromise.
- Mark: we need a mention on Almanac, maybe a guest spot if possible.
- Linda: we hired a PR Consultant who developed a "one sheet" about the celebration activities, and will do a press release.
- There will be no exhibitors at the July event, but there could be a resource table if we want. Resources should be accessible. Cindy: we should cut back on paper. Agencies will be asked to provide accessible resources. Andy: we should put energy into the celebration aspect of July.

Greater MN ADA Celebrations

- Conflicts of Interest & Procedures
 - If anyone is planning to apply for funding for an ADA celebration, they must not be involved in this conversation.
 - Linda G: Accounting Director Bruce Lemke talked about this process. Bruce says that no committee members planning to apply can be involved in planning discussion.
 - Subcommittee will develop criteria for being involved.
- Scoring process for applications to be recommended. Outside entities will score them.

- We will no longer be going through the CIL's. A broader call will better serve the desired purpose.
- Cindy: Funds are limited, so we may not get big organizations to apply. \$3000 per recipient, 6 total recipients.
- We can reach out to larger organizations to participate, as long as they would not need money to do so. Joan can contact the U of M Disability Services. They would not have a conflict of interest since they would not need funds. This was one of the provisions in the grant.

Marketing/Branding Update

- Joan: there will be more ads in the near future.
- Andy: we are following the direction of our consultants.
- Linda: we will do radio spots, newspaper ads, etc.

Art Update

- Artists selected through a successful call for art.
- Craig knows three of the five chosen artists from VSA.
- Range of styles and abilities are represented.
- Two artists are doing three "fine art" posters each for poster campaign. Prints will be available at events.
- Artists are invited to the events.
- One graffiti piece by Josh Paisley is to be completed at the family day, and will be the stage backdrop in October.

Volunteer recruitment

- Ongoing. Karen is reaching out to people.
- Training will be the morning of the family day.

Fundraising

- Legacy budget was sent to the committee.
- Approx. \$50,000 raised so far.
- Andy will meet with Linda Kelly from Allina this week.
- \$9,502.84 in VSA's ADA balance.
